STUDY/DIALOGUE SESSION: The Board met in its entirety – Scott Benefield, President; Jane Barnes, First Vice President; Dave Thomas, Second Vice President; Sue Marinelli, Secretary; Richard Rush, Treasurer - in study/dialogue session at 4:47 p.m. in the Seminar Room at Education Center, Golden, Colorado. Cindy Stevenson, superintendent, represented the administration.

PURPOSE: The Board met to interview applicants for student advisor to the Board of Education.

DISCUSSION: Every 10 minutes the Board of Education and superintendent interviewed a student interested in being a student advisor to the Board. In total, nine students had applied: one student was unable to make the interview and two previously interested students declined to continue in the application process as the second semester approached.

CONCLUSION: The Board members thanked each student interviewed and reviewed how the Board vote on student advisors would take place later that evening.

1. **PRELIMINARY**

01. **CALL TO ORDER:** A regular meeting was called to order by Scott Benefield, president of the Board of Education, at 6:09 p.m. in the Board Room of the Education Services Center, 1829 Denver West Drive, Golden, Colorado, Thursday, November 20, 2008.

02. **WELCOME TO THE AUDIENCE:** Mr. Benefield welcomed the audience and acknowledged the Lakewood High School Encore group and their director, Teri Willmarth.

Cynthia Stevenson, Superintendent, represented the administration.

Judy Hindman and VJ Johnston, Student Services, were recognized for receiving the Outstanding Partnership Award from the Rocky Mountain Center for Health Promotion.

The Board of Education honored Jeffco Public Schools as the 2nd place winner in the fifth annual Digital School Districts Survey. Don Jenkins and John Canuel received the award on behalf of the Educational Technology Services office and Information Technology department.

The Board of Education recognized Evan Appel, Dakota Ridge High School, for winning first place at the 2008 state cross country track competition. Dr. Jim Jelinek, principal at Dakota Ridge High School, received the award in Evan's absence.

The Board of Education recognized the Green Mountain High School gymnastics team and their coach for winning the state 5A gymnastics championship.

The Board of Education recognized the Evergreen High School gymnastics team and their coach for winning the state 4A gymnastics championship.

RESOLUTION

Denying a Charter to Global Outreach Charter Academy

WHEREAS, on September 18, 2008, the Board of Education of Jefferson County School District No. R-1 received a charter school application from the Global Outreach Charter Academy ("GOCA"); and

WHEREAS, the charter school application has been reviewed by the District's Charter School Review Committee and by members of the Superintendent's Cabinet; and

WHEREAS, Charter School Review Committee Comments, a Budget Department Crucial Questions Report, a Facilities Planning Crucial Questions Report, a Department of Learning and Educational Achievement Report, an Instructional Services Crucial Questions Report, a Special Populations Crucial Questions Report, and a District Wide Crucial Questions Report have been prepared to assist the Board based on the reviews conducted by the Charter School Review Committee and members of the Superintendent's Cabinet (attached hereto as Exhibits A - G, respectively); and

WHEREAS, the District's Accountability Committee and the Board have reviewed the charter school application in accordance with the requirements of C.R.S. §§ 22-30.5-107(1) & (1.5); and

WHEREAS, the Board scheduled a public meeting on October 16, 2008 in accordance with the requirements of C.R.S. § 22-30.5-107(2), at which representatives of GOCA made a presentation to and received questions from the Board; and

WHEREAS, the Charter Schools Act requires the Board to rule by resolution on the charter school application within 75 days after its receipt; and

WHEREAS, the Board has considered the charter school application; additional information provided by GOCA at the public meeting; the Charter Schools Act; District policies and regulations; and the Comments and Crucial Questions Reports prepared by the Charter School Review Committee and members of the Superintendent's Cabinet.

NOW, THEREFORE, BE IT RESOLVED by the Board that denial of the GOCA charter school application is in the best interests of the District, its students and the community, and the GOCA charter school application is hereby denied, for the following reasons:

1. In creating the Charter Schools Act, the general assembly intended to establish an avenue for the implementation of diverse and innovative, researched-based methods for educating children, and to expand educational opportunities for low achieving students. C.R.S. § 22-30.5-102(2)(a), (b), (c) and (f). The educational program offered by GOCA does not provide for

anything new or innovative (except for providing Russian language instruction as a class for credit) and replicates the instructional model of a typical neighborhood school. The initial application inferred that an ESL program was to be implemented throughout the educational program. However, the applicant has since clarified that no accepted ESL model would be implemented and that the only linguistic element of the program would be the teaching of Russian as a class.

2. The proposed school appears to be designed primarily to facilitate and encourage the cultural segregation of a specific ethnic group as opposed to promoting rigorous standards of pupil performance, expanding learning for low achieving students and encouraging a diverse or innovative approach to learning. The acknowledged target population is students from Russian and other Slavic cultures. The encouragement of such cultural segregation is at odds with the District's commitment to encouraging students to "develop their potential as productive global citizens in a 21st century environment." The applicants also have not provided any research-based evidence that the cultural and linguistic segregation encourage by the school will improve learning for its targeted students.

3. The proposed school does not address any unmet need in the District. Information from the District's Multicultural Office indicates a relatively small number of Slavic language students in the Jeffco community overall. Allendale Elementary School, which is in the general vicinity of the church where GOCA has proposed to locate its program, is a high performing school. Allendale has been developing a program to address the needs of the concentration of Slavic language students in its community. In the past year a new Principal has been appointed, a full day kindergarten has been created, a full time ESL teacher has been assigned to the school and programs to further assist the students are being developed.


4. GOCA has not provided a staffing structure that is educationally or financially sound. The GOCA budget provides for only 9 teaching staff for a projected enrollment of 252 (average class of 28 if they are perfectly balanced) in nine grade levels and does not provide staff for any elective activities or the planned Russian instruction for all students. The GOCA budget provides for 4 administrators for a staff of nine and an initial enrollment of 252.

5. Pursuant to the Act, charter schools are to be governed and administered by a governing body and in a manner agreed to by the applicant and the Board. C.R.S. § 22-30.5-104(4). There is a complete lack of Jefferson County representation on the founding governing board. Three of current board members live in Jacksonville, Florida; the other two are from Northglenn and Thornton, Colorado.



RESOLUTION

Denying a Charter to Lotus School for Excellence

WHEREAS, on September 18, 2008, the Board of Education of Jefferson County School District No. R-1 received a charter school application from the Lotus School for Excellence (“LSE”); and

WHEREAS, the charter school application has been reviewed by the District’s Charter School Review Committee and by members of the Superintendent’s Cabinet; and

WHEREAS, Charter School Review Committee Comments, a Budget Department Crucial Questions Report, a Facilities Planning Crucial Questions Report, a Department of Learning and Educational Achievement Report, an Instructional Services Crucial Questions Report, a Special Populations Crucial Questions Report, and a District Wide Crucial Questions Report have been prepared to assist the Board based on the reviews conducted by the Charter School Review Committee and members of the Superintendent’s Cabinet (attached hereto as Exhibits A - G, respectively); and

WHEREAS, the District’s Accountability Committee and the Board have reviewed the charter school application in accordance with the requirements of C.R.S. §§ 22-30.5-107(1) & (1.5); and

WHEREAS, the Board scheduled a public meeting on October 16, 2008 in accordance with the requirements of C.R.S. § 22-30.5-107(2), at which representatives of LSE made a presentation to and received questions from the Board; and

WHEREAS, the Board has also considered additional information from LSE submitted to the District on October 27, 2008; and

WHEREAS, the Charter Schools Act requires the Board to rule by resolution on the charter school application within 75 days after its receipt; and

WHEREAS, the Board has considered the charter school application and additional information provided by LSE; the Charter Schools Act; District policies and regulations; and the Comments and Crucial Questions Reports prepared by the Charter School Review Committee and members of the Superintendent’s Cabinet.

NOW, THEREFORE, BE IT RESOLVED by the Board that denial of the LSE charter school application is in the best interests of the District, its students and the community, and the LSE charter school application is hereby denied, for the following reasons:

1. LSE and the individuals submitting this application for a charter school in Jeffco, currently operate a charter school in the Aurora Public Schools (“APS”). LSE in APS, at this

time, has not demonstrated the success that is promised. Students at the school score below APS district averages in math and science at all grade levels except 6th grade where the math score is just slightly above the district average. However, the APS average is well below the average score for the state of Colorado. LSE Aurora scores are low despite the fact that the number of students tested decreases from year to year and, as LSE acknowledged at its public hearing, students who find the program too challenging leave the school. If students who cannot perform are leaving, then scores would be expected to improve from one year to the next. However, this is not occurring.

2. APS has reported that LSE was on academic watch this past year. In its annual evaluation by the APS Board, serious deficiencies in the school's management and governance structure were noted. As currently proposed, the same board will oversee both the APS and Jeffco LSE schools.

3. LSE in Aurora received a very negative financial audit report from APS indicating that the school's financial condition is poor.

4. LSE in Aurora has not met the instructional, financial, educational and governance expectations that were promised in their application in APS, and which have been promised in Jeffco. This suggests that the group of people managing the school in APS, who are the same people who are applying in Jeffco, may not currently have the ability to manage a second school for success.

5. Pursuant to the Charter Schools Act, charter schools are to be governed and administered by a governing body and in a manner agreed to by the applicant and the Board. C.R.S. § 22-30.5-104(4). There is a lack of parent representation on the LSE governing board. As outlined in the application, the current Lotus School For Excellence Incorporated (LSE Inc.) Board of Directors will direct LSE in Jeffco. This governing board also operates the LSE school in APS. There is no indication that any of the members of the current governing board have any connection to Jefferson County, nor is there any indication of an intent to involve Jefferson County parents, or any parents for that matter, in the governance of the school, other than through participation on an accountability committee. Rather than being parent-initiated and parent-supported, this is a business venture promoted by a corporation whose board of directors are unknown to and have no connection with the Jeffco school community.

6. The Act requires LSE to demonstrate that a sufficient number of District parents, teachers, or pupils not only support the formation of the proposed charter school but provide an adequate base for the proposed enrollment numbers during the requested term of the charter. C.R.S. § 22-30.5-106(1)(c). LSE has failed to provide adequate evidence of such support. Pursuant to C.R.S. § 22-30.5-106(3), the District asked LSE to provide aggregate information concerning the grade levels and school in which prospective pupils are enrolled. LSE responded that they were not able to provide that information.


7. The Board is willing to reconsider Lotus' application at a later time, if Lotus can demonstrate that the school it is currently operating in APS can be educationally and financially

successful; that it can adequately involve Jeffco parents and citizens in its governance; and that there is adequate evidence of support and proposed enrollment.


In accordance with C.R.S. § 22-30.5-107(4), the District administration is hereby directed to provide a copy of this Resolution to the Colorado Department of Education within fifteen days of its adoption date.


