## 2.01 Superintendent Goals 2016/17

The study session was called to order at 5:00 p.m. by Ron Mitchell, president of the Board of Education, in the Board Room, Education Center, 1829 Denver West Dr., Golden, Colorado, Thursday, December 1, 2016.
